International Character of the UvA and Amsterdam

About our Exchange Programme

Through our exchange programme, students can immerse themselves in our vibrant campus, gain global perspectives, build lifelong connections, access world-class education, and enriching cultural experiences. They are invited to join us to shape their future through international collaboration.

Entry requirements

English proficiency: Both Bachelor's and Master's students should have a good English language proficiency. Required scores of one of the following tests:

- TOEFL (0-120): minimum total score of 92 with a minimum of 22 per section
- TOEFL (1-6): minimum total score of 4.5 with a minimum per subscore: Reading 4.5, Listening 5.0, Speaking 4.0, Writing 4.5.
- IELTS: overall band of 6.5 with a minimum of 6.0 per section.
- Cambridge: 180 overall and in each skill

Bachelor's students: completion of at least two full academic years of courses in economics, business or an equivalent field of study, including courses in mathematics and statistics and at least 90 ECTS obtained (or the equivalent in local credits) by the start of the exchange at the UvA.

Master's students: Bachelor's degree obtained and meeting the **entry requirements** of the Master's programme they wish to take courses from.

Nomination and Application

Exchange students from partner universities will be nominated by their home university. After we have accepted the nomination by the home university, the student will receive a UvAnetID (student number) and an invitation to start the application. Courses

The list of courses that we offer to exchange students can be found in the [UvA Course Catalogue](#). Please bear in mind that the Master's course offer is limited in semester 2; an exchange in semester 1 is a better option for Master's exchange students.

Grades and Transcripts

UvA Grading Scheme: from 1 (lowest score) to 10 (highest score).

We will send the transcripts to the home university by e-mail. Independent exchange students (free movers) will receive the transcript themselves.

Transcripts will be sent:

- mid March for semester 1 students
- mid August for semester 2 and full year students

Housing

The UvA housing service unfortunately cannot guarantee housing as there is a shortage of student housing in Amsterdam. Read all about [how to find a room in Amsterdam](#).

Study visa and study residence permit

Students from outside the EU/EEA need to have a [residence permit and/or an entry visa](#). Students with a Chinese nationality have to meet the English language requirements in order to be eligible for a Dutch entry visa (even if you currently live/study outside China).

Insurance

All international students are required by law to have appropriate health [insurance](#) for the duration of their stay in the Netherlands. A liability insurance is advised.

Approximate Costs of Living

During their stay in Amsterdam, students can expect to spend between €975 and €1,600 per month on living expenses. Costs are roughly as follows:

- accommodation: €375 - €1200 per month
- general living expenses: €400 - €500 per month
- insurance: €35 - €100 per month
- books: €50 - €100 per month
- secondhand bike (optional): €100 - €200, [about cycling in Amsterdam](#)
- public transport (optional): €40 - €100 per month
